AGM Results:

Welcome to your new Chairman, Rev Canon John Rees and the new vice chair, the Worshipful Mark Hill QC and Darren Oliver as the new Treasurer. In addition, in a contested election, Mark Emerton and the Venerable Stuart Beake were re-elected to the committee and Venerable Simon Baker was elected for the first time. And the new Chair and Committee got down to business pretty quickly.

Set in the elegant surroundings of the Marriott Hotel fronting onto Cathedral Green and backing onto the Wharfeside district, the conference included examples of the comedic potential, as well as the serious business, of death. The opening dinner was graced with a delightful review of his acquaintance with the subject from the 'lead Bishop for death', Geoffrey Rowell. Saturday morning opened with Professor Douglas Davies, illustrating that it is possible to ask awkward questions about death, even if politicians avoid them Rev Dr Sandra Millar from the Funerals Project challenged us with stats that show the Church of England remains a significant player in the funeral market, 1/3 of all funerals each week, but cannot afford to be complacent. Amongst other things Frank Cranmer considered cross border difficulties created by differences between England and Scotland's death and burial law. Disappointingly Rupert Bursell QC declined to use a skull to illustrate themes from Hamlet, Ophelia's suicide and burial but it was an entertaining talk all the same.

Standing in for the late and lamented Andrew Johnson, former Registrar of Winchester and Salisbury, a crack team from Lee Bolton Mounier Williams shared the benefits of their experience over five different Dioceses. Their presentation covered, amongst other things, relaxing rules on monuments, building on churchyards, re-use of open churchyards and maintenance. Joseph Elders, from the Churches Building Council reviewed CBC's archaeological concerns, with monuments, natural features and ecology above ground and human remains, 'more than bones', below ground. Finally, Julia Rugg challenged the church to take a more active and national role in addressing the urgent need for more burial space, which on current projections could run out in as little as a decade or so. The talks provided much material for consideration in workshops and for Mark Hill's conference summary on Sunday morning. He called for facilitative not oppressive funeral law, retaining residential rights of burial as a Church of England hallmark, commended Grave Talk and funeral project initiatives. He concluded with a salutary anecdote about the wrong music at the crem, ('Smoke gets in your eyes' instead of 'Every time you say goodbye'!). As with all good funerals there was a thanksgiving for the life of the Society in the form of Bishop Christopher's poignantly valedictory keynote speech. Thankfully though the Society goes on and though no longer the Chair so does Bishop Christopher.
