Ecclesiastical Law Society Working Group paper on Reform and Renewal...

A small but beautiful working group has produced a response to the Enabling Measure being proposed as part of the Reform and Renewal process reported in last month's newsletter. A Message from the Chair - There will be General Synod elections taking place in every diocese of the Church of England during the next few months. Those members of the ELS who are eligible to stand and/or vote may wish to consider whether they should stand as candidates, or at least engage with those who do stand in their dioceses, if they are qualified to vote. The General Synod is the Church of England's legislative assembly, but there has been a noticeable decline in the number of legally-qualified members in recent years, and it would be good if more members of our own Society were to bring their insights to bear on the Synod's work. General Synod Meeting 10th to 13th July at York

Appointments: Approval was given to the appointment of William Nye as the new Secretary General to the Archbishop's Council and the General Synod and to the appointment of Matthew Frost to fill a vacancy in the Archbishop's Council.

Legislative changes:

Administration of Holy Communion: Regulations to relax the rules for giving authority to administer Holy Communion were finalized. In future it will be possible for decisions about authorization to be delegated by the Bishop (including to a parish priest) and for authority to be given not only to those who are confirmed but also to baptized children who have been admitted to Holy Communion under the 2006 Regulations.

Simplification: The first legislation under the simplification process was brought forward to make changes to the Terms of Service Regulations. These include dispensing with the need for a sick certificate for non-stipendiary clergy, allowing curates' training posts to be extended by a year to assist in finding their next post and making provision for a new type of fixed term appointment in the form of "interim posts" which may be helpful for example, where a short-term appointment is needed to turn around a declining parish or to deal with the consequences of a breakdown in parish relationships.

Faculty Jurisdiction and Property: The Synod approved a comprehensive set of Faculty Jurisdiction Rules, in terms reflecting the Care of Churches and Ecclesiastical Jurisdiction (Amendment) Measure 2015 to further simplify the Faculty system.

The Synod also approved an Order made under the Ecclesiastical Property Measure 2015 allowing PCCs to dispose of property without the consent of the diocesan authority in certain circumstances. The Measure already allows PCCs to grant leases for up to 7 years without consent of the diocesan authority (generally the DBF). The Order gives further freedom by allowing PCCs to dispose of property, without such consent, for a value up to 100% of a PCC's unrestricted income or a maximum of £250,000. Consent will still be needed for disposal of church buildings, churchyards and licensed places of worship and of land adjoining them. The title to any such property will however remain with the Diocesan Authority, and no PCC can take advantage of the power unless its accounts are up to date. Interestingly there is no reference to contributions to Common Fund or parish share being up to date.

Safeguarding: The Synod gave Final Approval to the Safeguarding and Clergy Discipline Measure, and the associated Amending Canon No.34, which between them give effect to a package intended to make the Church's disciplinary processes more effective when safeguarding issues arise and by strengthening the Church's wider legal framework in relation to safeguarding. The package makes mandatory the appointment of Diocesan Safeguarding Advisers and safeguarding training for clergy. It also includes provisions:

- Extending bishops' powers of suspension to cases where a local authority or the police provide information which leads the bishop to be satisfied that a cleric presents a significant risk of harm;
- Allowing a bishop to suspend a churchwarden or PCC member in similar circumstances;
- Disqualifying a churchwarden or PCC member from office if they are on a statutory barred list:
- Requiring office holders in the church to have 'due regard' to safeguarding advice issued by the House of Bishops;
- Removing the current one year limitation period that applies generally to complaints of clergy misconduct in relation to complaints of clergy sexual misconduct towards children and vulnerable adults and
- Empowering bishops to direct clergy and licensed readers and lay workers to undergo a risk assessment.

A couple of other issues of concern:

Leadership and Minority Ethnic Anglicans: A report from the Committee for Minority Ethnic Anglican Concerns (CMEAC) called for leadership at all levels of the Church to reflect the multicultural reality of our society.

Climate change: The debate on climate change resulted from the tabling of motions by five Dioceses. A motion was passed noting the duty to steward the earth, the disproportionate impact of climate change on the world's poorest, faith-based involvement in international fora to curb carbon emissions and redirect fossil fuel subsidies to renewable or lower carbon energy and to raise awareness of eco-theology within the church.

ELS sponsors the Inter-Inn Mooting Competition

The 2015 Inter-Inn Mooting Competition concluded with the final on Monday 13 July held in the Parliament Chamber of Inner Temple. The event was sponsored by the Ecclesiastical Law Society which provided a £500 cash prize to the winning team to accompany the shield. David Harte was instrumental in organising the event in collaboration with Sharin Cockerton, President of the Inner Temple Mooting Committee, which was hosting the event.

David devised two moot problems on matters of ecclesiastical law, one of which was used for the semi-finals. In the final the team from Inner Temple represented the Appellants with Gray's Inn acting for the Respondents. The appeal arose from an imaginative probate action in the Chancery Division concerning ownership of a painting which an incumbent, since deceased, had placed in a church. The executors queried whether the painting formed part of the estate. In a judgment delivered by Sir Colin Rimer (with which the rest of the court agreed) the appeal was allowed.

As to the competition, William Horwood and Daisy Noble of Gray's Inn were declared the winners. The Inter-Inn Mooting Shield was presented by Sir Colin and the ELS cheques by Chancellor Mark Hill QC, Vice-Chairman of the Ecclesiastical Law Society. Many thanks are due to David Harte for overseeing this initiative on behalf of the Ecclesiastical Law Society and to all those who kindly judged both the semi-finals and the final.
