#### **EDITORIAL**

Anglican canon law not being my starter for ten (nor, indeed, my starter for any number you care to mention), consistory court judgments tend to pass me by. One recent decision that did catch my eye, however, was *Re All Saints Rothbury* [2018] ECC New 3. The petition proposed various works of which the contentious item was a safety-rope in the spiral staircase of the tower up to the ringing-chamber. The church architect proposed a rope running down the outer radius of the stairs because there was an electrical cable conduit running down the inner radius. The objector, on behalf of the local ringers, wanted a rope down the *inner* radius instead, because an outer rope would tend to force anyone climbing the tower towards the narrower part of a very narrow staircase. Chancellor Duff granted a faculty for a safety rope running down the inner radius, with fixing points at intervals.

Having climbed a few towers without any kind of rope or handrail  $at \ all -$  and knowing just how scary that can be -1 was firmly with the Rothbury ringers on this one. [FC]

#### DIOCESE OF OXFORD: INDEPENDENT CASE REVIEW

On 28 December 2017, the Revd Tim Davis was found guilty of conduct unbecoming or inappropriate to the office and work of a clerk in Holy Orders through the abuse of spiritual power and authority over a person then aged 15-16. The penalty imposed under the CDM

2003 was immediate cessation of office and prohibition from the exercise of holy orders for a period of two years, effective from 12 March 2018.

The Diocese of Oxford has now commissioned an Independent Case Review of the reporting, investigation and management of allegations and concerns about the conduct of Mr Davis. It will be undertaken by Amanda Lamb, a specialist in safeguarding, and Chancellor Timothy Briden. [FC]

## ST GEORGE'S, HEADSTONE

Sir William Fittall, the Independent Reviewer, has published his report, *Grievance from the PCC of St George's Headstone*, about matters relating to episcopal oversight for the church. The dispute resulted from a resolution passed on 31 October by the PCC of St George's Headstone in the Diocese of London which authorized the institution of a grievance against the Bishop of London under The Declaration on the Ministry of Bishops and Priests (Resolution of Disputes Procedure) Regulations 2014. He concluded that the grievance was unjustified. [FC]

#### CAN A MONK BE A LAWYER?

Some members of this Society will be astonished that one might even bother to ask. However, in *Monachos Eirinaios* [2018] EUECJ C-431/17\_O, Advocate General Sharpston has had to deal with precisely that question.

The Greek Council of State sought an advisory opinion from the CJEU on whether it is compatible with Directive 98/5/EC (on mutual recognition of legal qualifications) for the Athens Bar Association to refuse to register Monachos Eirinaios, a monk qualified in Cyprus and a member of the Cyprus Bar Association, as a lawyer practising under his home-country professional credentials on the ground that monks simply cannot, under Greek national law, be entered in the registers of bar associations. The decision of the Athens Bar Association was based on Article 8(1) of a Presidential Decree that provides that the national rules on incompatibilities (specifically, being a clergyman or a monk) also apply to lawyers from other EU jurisdictions who want to practise in Greece.

Unsurprisingly, AG Sharpston advises that Directive 98/5/EC precludes the application of a national rule prohibiting a person from being registered as a lawyer under his home-country professional title on the grounds that he is a monk and does not permit a Member State automatically to ban a person qualified in his home-country 'on the grounds that, as a person under religious discipline, he cannot by definition conduct himself in the manner required to provide the guarantees necessary for practice as a lawyer'.
