A NOTE FROM THE CHAIRMAN: RESIDENTIAL CONFERENCE 2021 CANCELLED

At a recent meeting of the Trustees a unanimous decision was taken, with sadness and regret, to cancel the Society's Residential Conference scheduled to take place in Newcastle on 19-21 March 2021 on the subject of *The Solemnisation of Marriage—Past, Present and Future*. With uncertainties persisting as to when large-scale gatherings might be possible in the future, and noting that the return to normality for travel and accommodation was still some considerable way off, it could not be guaranteed either that the event could proceed or that a sufficient number of people would be willing or able to attend to make it viable. The prospect of deferring a decision was rejected as this would expose the Society to financial liabilities, whereas this timely cancellation has cost the Society nothing.

We are grateful to the principal speakers who have agreed to participate in a virtual conference on **Saturday 20 March 2021** when their papers can be presented and discussed remotely. Please note this date in your diary. Further details will be circulated after the summer break.

Trust Registration Service update

HMRC has published a summary of responses to the Technical Consultation on the Fifth Money Laundering Directive and the Trust Registration Service (TRS), which includes proposed regulations. The original intention was that charities in England and Wales currently excepted from registration and charities with an income of under £5,000—as well as charities in Northern Ireland that are waiting to register with the CCNI and Scottish charities—would need to register with the TRS. The proposal caused some consternation among small unregistered congregations; however, the Government has now decided that, in general, charities will *not* be required to register with the TRS. The draft Regulations insert a new Schedule 3A (Excluded Trusts) into the Money Laundering, Terrorist Financing and Transfer of Funds (Information on the Payer) Regulations 2017 which includes the following exemption:

'Charitable trusts

- 5. A trust for charitable purposes which—
 - (a) in Scotland or Northern Ireland, is registered as a charity; or
 - (b) in England and Wales, is registered as a charity or not required to register by virtue of section 30(2)(a) to (d) of the Charities Act 2011(c).'

Legislation update

The Channel Islands Measure 2020 has received Royal Assent. The Measure makes provision for the attachment of the Channel Islands to the diocese of Salisbury; the application of Church Measures to the Channel Islands; and for Church representation for the Channel Islands.
